## ADMINISTRATIVE CIRCULAR NO. 181 DATE 13/10/2008

Sub: Enhancement of the rate of stipend for Graduate, Technician and Technician (Vocational) Apprentices.

The Directorate General of Employment and Training, Ministry of Labour and Employment, Govt. of India, New Delhi vide their Notification under C.S.R.17(E) dated 07/01/2008 had further amended the Apprenticeship Rules, 1992. A copy of the Notification is attached herewith.

2. As per the Circular, the rate of stipend for Graduate, Technician and Technician (Vocational) Apprentices has to be amended w.e.f. 08/01/2008 which are as follows:-

- া. (1) इन नियमों का संक्षिप्त नाम शिक्षुता (संशोधन) नियम, 200৪ है।
  - (2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. शिक्षुता नियम, 1992 के नियम 11 के उप-नियम (2) के खंड (क), खंड (ख), खंड (ग), खंड (घ) और खंड (ङ) और उनसे संबंधित प्रविष्टियों के स्थान पर निम्नलिखित रखा जाएगा, अर्थात् :-

"(क) स्नातक शिक्षु

2600 रु. प्रतिमाह

(ख) सेंडविच कोर्स

1850 रु. प्रतिमाह

(डिग्री संस्थाओं से विद्यार्थी)

1850 रु. प्रतिमाह

(ग) तकनीकी शिक्षु

(घ) सेंडविच कांसी (डिप्लोमा संस्थाओं से विद्यार्थी)

1510 रु. प्रतिमाह

(ङ) तकनीशियन (व्यवसायिक) शिक्ष

1440 रु. प्रतिमाह"।

## NOTIFICATION

New Delhi, the 7th January, 2008

G.S.R. 17(E).—In exercise of the powers conferred by sub-section (1) of Section 37 of the Apprentices Act, 1961 (52 of 1961) and after consulting the Central Apprenticeship Council, the Central Government hereby makes the following rules further to amend the Apprenticeship Rules, 1992, namely:—

- 1. (1) These rules may be called the Apprenticeship (Amendment) Rules, 2008.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Apprenticeship Rules 1992, in rule 11, in sub-rule (2) for clauses (a), (b), (c), (d) and (e) and entries relating thereto, the following shall be substituted, namely:—

"(a)	Graduate Apprentices	Rs. 2600 per month
(b)	Sandwich Course (Students from Degree Institutions)	Rs. 1850 per month
(c)	Technician Apprentices .	Rs. 1850 per month
(d)	Sandwich Course (Students from Diploma Institutions)	Rs. 1510 per month
(e)	Technician (Vocational) Apprentices	Rs. 1440 per month".
