ADMINISTRATIVE CIRCULAR NO. 186 DATE 22 / 10 / 2008

Sub:Payment of Ex-gratia for the year 2007-08 and advance against wage revision arrears

The performance of the Company after unbundling of the erstwhile MSEDCL has been compared on year to year basis and it has been observed that there is remarkable improvement in the areas of reduction in line loss, energy audit, anti theft drives, collection efficiency etc. during the year 2007-2008. The Company believes that, these improvements are due to continuous efforts made by the employees. Therefore, the issue regarding grant of Ex-gratia payment for the year 2007-08 and advance against wage revision due w.e.f 01/04/2008 were under consideration of the Company. The payment of Ex-gratia and advance against wage revision being a common issues were discussed during the meeting of the Managing Directors of all the three Companies.

2. Now, the Managing Director, MSEDCL in consultation with Director (Finance) and Director (Operations) has accorded approval as under :-

a) Payment of Ex-gratia of Rs.7000/- (Rs. Seven Thousand only) for the year 2007-08 to all Officers / employees including daily rated employees who have worked during the year 2007-08.

b) Payment of advance of Rs.3000/- (Rs.Three Thousand only) to all officers/employees against wage revision arrears due w.e.f. 01/04/2008. This advance will be adjusted against final payment of wage revision arrears.

3. The employees who have worked during the part period of the financial year 2007-08 shall be eligible for Ex-gratia payment on pro-rata basis.

4. The payment of Ex-gratia is restricted to the year 2007-08 only and is not to be taken as precedent for the coming years.

5. The payment of Ex-gratia and advance against wage revision should be made to the Officers/employees on 27/10/2008. The payment of Ex-gratia and advance against wage revision should be drawn and paid by the office where the employees are working on the date of issue of this circular irrespective of place of working of the employees during the financial year 2007-2008. The necessary entries regarding payment of Ex-gratia and advance against wage revision should be made in the service Books of the employees concerned before actually effecting payment of Ex-gratia.

6. The concerned drawing and disbursing Officer should send requirement of funds towards payment of Ex-gratia and advance against wage revision to the Manager (F&A-WM), Hongkong Bank Building, Mumbai immediately.
