**ADMINISTRATIVE CIRCULAR NO. 341 DATE 30 / 05 / 2011**

Sub : Enhancement of the rate of stipend for Graduate, Technician and Technician (Vocational) Apprentices.

The Directorate General of Employment and Training, Ministry of Labour and Employment, Govt. of India, New Delhi vide their Notification under G.S.R.228(E) dated 23/03/2011 had further amended the Apprenticeship Rules, 1992. A copy of the Notification is attached herewith.

2. As per the Board of Apprenticeship Training (W.R), Mumbai Circular dated 19.05.2011, the rate of stipend for Graduate, Technician and Technician (Vocational) Apprentices has to be amended w.e.f. 23/03/2011 which are as follows :-

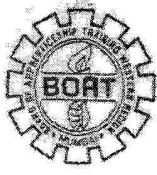

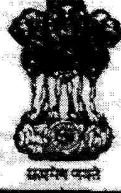

G.S.R. 228(E).—In exercise of the powers conferred by sub-section (1) of Section 37 of the Apprentices Act, 1961 (52 of 1961), the Central Government, after consulting the Central Apprenticeship Council, hereby makes the following rules further to amend the Apprenticeship Rules, 1992, namely :—

1. (1) These rules may be called the Apprenticeship (Amendment) Rules, 2011.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Apprenticeship Rules, 1992, in rule 11, in sub-rule (2), for clauses (a), (b), (c), (d) and (e) and the entries relating thereto, the following shall be substituted, namely :—
