ADMINISTRATIVE CIRCULAR NO. 43 DATE 8/5/2006

Sub : Change in the nomenclature of the post of Information and Public Relations Cadre.

Consequent upon restructuring of the erstwhile MSEB, the nomenclature of some of the posts in Personnel and Accounts Department have been changed as C.G.M.(P), G.M.(P), C.G.M.(F&A), G.M.(F&A) etc. with the same powers and authority of their respective posts.


2. On the same lines, a proposal to change the existing nomenclature of the posts of CI&PRO, Dy.CI&PRO and I&PRO was under consideration.

3. Now, in exercise of the powers delegated vide Adm.Cir.No.1 dated 29/9/2005, the Managing Director(MSEDCL) in consultation with Director(Finance) has accorded approval to change the existing nomenclature of the posts of CI&PRO, Dy.CI&PRO and I&PRO. Accordingly, the revised nomenclature of the posts of **Chief Information & Public Relations Officer**, **Dy.Chief Information & Public Relations Officer** and **Information & Public Relations Officer of MSEDCL** in English and Marathi shall be as under:-

1.	Chief Information & Public Relations Officer (CI&PRO)	Chief Public Relations Officer (C.P.R.O.) मुख्य जनसंपर्क अधिकारी
2.	Dy.Chief Information & Public Relations Officer (Dy.CI&PRO)	Dy.Chief Public Relations Officer (Dy.C.P.R.O.) उप मुख्य जनसंपर्क अधिकारी
3.	Information & Public Relations Officer (I&PRO)	Public Relations Officer (P.R.O.) जनसंपर्क अधिकारी

4. Consequently, the present nomenclature of the above posts wherever appearing in the Classification & Recruitment Regulations, Employees' Service Regulations, Employees' Seniority Regulations as well as other G.Os., G.S.Os. of the erstwhile MSEB shall stand replaced as above.

5. This Administrative Circular comes into force with immediate effect.
