ADMINISTRATIVE CIRCULAR NO. 460 DATE 24 / 06 / 2013

Sub : Training Scheme for non-qualified dependents notified under
G.O.159 (P) dated 30/06/2004.

Read : C.S.No.1 dated 22/03/2005 to G.O.159 (P) dt.30/06/2004

The issue regarding providing training in to non-qualified dependents from to consider them eligible for appointment to the post of 'Junior Technician' was under consideration sometime in the past.

2. Now, the Managing Director, in consultation with the Director (Finance), Director (Operations) and Director (Projects) has accorded approval to depute the non qualified dependents from all categories (Backward Class as well as open) eligible for appointment under the scheme of Compassionate Appointment, for ITI Sandwich Course for the year 2013-2014 under the training scheme formulated vide G.O.159 (P) dated 30/6/2004 read with C.S.No.1 dated 22/03/2005 in accordance with Government Resolution No ITI-2012/Pra.kra.170/Prof. Edu.-3 dated 30/04/2013.


3. The Government has also notified a batch of 21 candidates in the 23 Training Centres to impart the ITI Training to the non qualified dependents of the deceased employees. Accordingly, the candidates shall be deputed to this Training Course as per the allocation provided vide Annexure – 'A' enclosed with this Administrative Circular.

4. The terms and conditions of training shall be as under:-

- (i) The Training Course will start from 01/08/2013.
- (ii) The candidates of the age of 45 years or below as on the date of commencement of sandwich course i.e. 01/08/2013 and whose applications have been received on or before 30/06/2013, shall be eligible for the proposed I.T.I. Training.
- (iii) The non-qualified dependents deputed for training pursuant to this Administrative Circular shall not have any right for immediate employment. The time limit for providing regular employment/absorption also cannot be assured. An explicit condition to this effect shall be incorporated in the Training Order.

- (iv) The non-qualified dependents after successful completion of their training shall be kept on waiting list and shall be absorbed / appointed as per the method of filling in the post of 'Junior Technician' as applicable at that time, against the vacancies occurring in near future according to roster.
- (v) Initially, the training cost of Rs.15,000/- per candidate (including examination fees) or as decided by the Director (Training), Technical Education and Training, Government of Maharashtra shall be incurred by the Company and the same shall be recovered from the concerned non-qualified dependents deputed for the aforesaid training in 12 equal monthly installments through their salary after providing them employment.
- (vi) A bond on the stamp paper of Rs.100/- (Rs. One hundred only) as per Annexure -'B' of this Circular, should be obtained from the dependent candidate before deputing for ITI Training.
- (vii) Other terms and conditions stipulated in G.O.No.159(P) dated 30/6/2004, Adm.Cir.No.425 dated 7/8/2004 and C.S.No.1 dated 22/3/2005 to G.O.159(P), Adm. Cir.No.103 dt.25/04/2007, Adm. Cir.No.161 dt.14/07/2008, Adm. Cir No 240 dt.24/08/2009 and Adm. Cir. No. 326 dt.27/12/2010 shall be applicable to the dependents to be deputed for training pursuant to this Administrative Circular.
5. The Managing Director has directed that the cases, which are complete in all respects as on 30/06/2013, should be considered for the training under this scheme.
6. The concerned Chief Engineers should prepare a batch of 21 candidates as per the seniority of the cases taking into account the places of residence of the dependents and ITI Institutes allotted by the Higher and Technical Education Department, Government of Maharashtra and should send the list of candidates to the respective Training Institute on or before 15th July, 2013 along with the Training fees as mentioned above positively.
