**ADMINISTRATIVE CIRCULAR NO. 545 DATED 15 / 10 / 2016**

Sub : Change in nomenclature of Vigilance & Security cadre.

After constitution of Energy Vigilance Committee (EVC), change in nomenclature of Vigilance & Security cadre was under consideration for sometime in the past. Now, the Board of Directors MSEDCL vide Resolution No.726 dated 19/09/2016 has resolved to change the nomenclature of Vigilance & Security cadre in the Company as 'Security & Enforcement (S&E)'. The change in nomenclature shall be without any change in present pay scale and status attached to the posts in the said cadre.
