## ADMINISTRATIVE CIRCULAR NO. 548 DATE 28/10/2016

Sub: Payment of EDP Allowance to the Officers/employees working in IT cadre.

Considering the changed scenario and to come up with the development and advancement in Information Technology field, the independent Information Technology Wing has been formed in the erstwhile MSEB / Company. To motivate and boost the morale of the Officers/employees working in the Information Technology cadre, the EDP allowance is being paid. These rates of EDP Allowance have been revised from time to time in the past. However, in spite of clear instructions regarding payment of EDP Allowance vide Administrative Circular No. 242 & 245 both dated 27/08/2009 and Administrative Circular No 487 & 489 both dated 30/06/2014, it has been noticed that difficulties are being faced by the field offices regarding applicability of EDP Allowance to the Officers/employees in IT Cadre.

- 2. The issue regarding applicability of EDP Allowance has been examined and to remove the disparity, the Chairman and Managing Director in consultation with Director (Finance), Director (Operations) and Director (Projects) has accorded approval for payment of EDP Allowance to all the Officers/employees working in IT cadre who have joined on 07/08/2009 or thereafter.
- 3. Accordingly, all the eligible Officers/employees in Information Technology Cadre who joined in the services of the Company on and after 07/08/2009 are entitled for EDP Allowance at the rate prescribed vide Administrative Circular No. 242 & 245 both dated 27/08/2009 and Administrative Circular No 487 & 489 both dated 30/06/2014.
- 4. Consequently, the Note below para 2 (e) of Adm. Cir. No 242 dated 27/08/2009, para 2 (F) of Adm. Cir. No 245 dated 27/08/2009, para 2 (e) of Adm. Cir. No 487 dated 30/06/2014 and para 2 (F) of Adm. Cir. No 489 dated 30/06/2014 shall stand deleted.
- 5. Further, as notified vide Administrative Circular No. 242 & 245 both dated 27/08/2009 and Administrative Circular No 487 & 489 both dated 30/06/2014, future course of action as regards to EDP Allowance shall be decided along with other allowances at the time of ensuing wage revision process.
