ADMINISTRATIVE CIRCULAR NO. 57 DATE 26/6/2006

Sub: Delegation of administrative powers under Internal Reforms.

Read: 1) G.O.No.157(P) dated 18/8/2003

2) C.S.No.3 dated 12/8/2005 to G.O.No.157(P) dated 18/8/2003

3) Adm.Cir.No.17 dated 6/2/2006

The delegation of administrative powers under Internal Reforms were notified vide G.O.No.157(P) dated 18/8/2003 and the period of its validity was extended upto 31/3/2006 vide C.S.No.3 dated 12/8/2005. The issue regarding extending the validity of administrative powers delegated under the said General Order to the in-charge of O&M Division or O&M Sub-Division, for effective implementation of Internal Reforms Programme was under consideration of MSEDCL for some time past.

2. Accordingly, the Managing Director, MSEDCL in consultation with Director (Operation) and Director (Finance) has accorded approval to extend the validity of the below mentioned administrative powers, delegated vide G.O.No.157(P) dt.18/8/2003 and extended vide C.S.No.3 dt.12/8/2005 to the said G.O., beyond 31/3/2006, until further orders.
