ADMINISTRATIVE CIRCULAR NO. 685 DATE 24 / 12 / 2024

Sub: Revised terms and conditions in Higher Grade Benefit.

Ref: 1) Administrative Circular No. 304 Dt. 28.07.2010.

2) Administrative Circular No. 342 Dt. 07.06.2011

An Anomaly Committee was constituted to discuss and propose remedy to various issues regarding anomaly due to Pay Revision for the period of 01.04.2018 to 31.03.2023. The Committee Members viz. Director (HR) of MSEDCL and MSETCL and Executive Director (HR) of MSPGCL, Director (Finance), MSEBHCL and Chief Industrial Relation Officers of all companies after examining the issues have recommended for revising the conditions prescribed for granting higher grade benefit on third occasion.

2. Now, the Chairman and Managing Director in consultation with Director (Finance), Director (Operation) and Director (HR) has accorded approval for adoption of recommendation of the Committee. Accordingly, the modalities for deciding higher grade benefit on 3rd occasion notified vide Administrative Circular No. 304 dated 28.07.2010 under para 2 (i)(a) shall be as under:

'While granting Higher Grade Benefit on 3rd occasion, if an employee availing Basic Pay less than that of he would have received on promotion, in that case the condition of factorization of promotion given in last three years to be exempted. In other case the condition shall prevail.'

- 3. All other terms and conditions mentioned therein Administrative Circular No. 304 dated 28.07.2010 shall remain unchanged. Also, few examples to exempt the condition of factorization of promotion are enclosed for ready reference as Annexure 'A' & 'B'.
- 4. It is also to be noted that as per the recommendation of the Anomaly Committee the NMR service shall not be counted for higher grade benefit on 3rd occasion.
- 5. This Administrative Circular is available on e-library of the Company.
