ADMINISTRATIVE CIRCULAR NO. 83 DATE 17/10/2006

Sub : Change in nomenclature and revising the pre-requisites of the existing post of 'Sr.Vehicle Foreman'.

The issue regarding change in nomenclature and revision in existing pre-requisites regarding qualification and method of filling the post of 'Sr.Vehicle Foreman' was under consideration for some time past.

2. After examining the issue thoroughly, the M.D., MSEDCL in consultation with the Director (Operation) and Director (Finance) has accorded approval to change the existing nomenclature of the post of 'Sr.Vehicle Foreman' appearing at Sr.No.7-A which shall now be replaced as Sr.No.3-A (under Sr.No.3 Sub Engr.Civil), in Pay Gr.III (Technical Posts) of Schedule A-1 of Classification and Recruitment Regulations, 1961 as under:-

Existing Nomenclature of the post	Revised Nomenclature of the post in English & Marathi
Senior Vehicle Foreman	<i>Sub-Engineer (Automobile)</i> दुय्यम अभियंता (स्वयंचल)

3. Consequently, the present nomenclature of the post of 'Sr.Vehicle Foreman', wherever appearing in the erstwhile MSEB Classification and Recruitment Regulations, Employees Service Regulations, Employees' Seniority Regulations as well as other G.Os, G.S.Os, Circulars etc., shall stand replaced as "*Sub-Engineer(Automobile)*".

4. The Managing Director in consultation with the Director (Operation) has also accorded approval to revise the existing pre-requisites regarding qualification, experience and method of filling the vacancies etc., of the post of 'Sr.Vehicle Foreman' now designated as "*Sub-Engineer (Automobile)*",


placed at Sr.No.3-A in Pay Gr.III (Technical Posts) of Schedule A-1 of Classification and Recruitment Regulations, 1961 as mentioned below:-
