ADMINISTRATIVE CIRCULAR NO. 88 DATE 07.11.2006

Sub: Revising the method of filling the vacancy of Vehicle Driver.

Consequent on application of the revised staffing pattern, the issue regarding filling the vacancy of Vehicle Driver was under consideration for sometime past.

- 2. Considering the revised staff set up and also with view to minimize the surplus posts of Cleaners, the M.D., MSEDCL in consultation with the Director (Operation) and Director (Finance) has accorded approval to modify the existing method of filling the vacancy of Vehicle Driver prescribed at Sr.No.16 under Pay Gr.III Non-Technical Posts in Schedule A-2 appended to the Classification and Recruitment Regulations (i.e.G.S.O.112 dated 12/2/1962).
- 3. Accordingly, the revised provision for filling the post of Vehicle Driver shall be as under:-

Vehicle Driver Rs.4305-135- 4980-150- 6480-165- 11760	By departmental promotion from amongst the existing Cleaners in the Board possessing light & heavy duty driving license and completed total 5 years or more service as Vehicle Cleaner provided they pass the departmental Driving Test. OR By Direct Recruitment.	(i) By departmental promotion from amongst the existing qualified Cleaners possessing light & heavy duty driving license and completed total 5 years or more service as Vehicle Cleaner provided they pass departmental Driving Test. (ii) After completing the process of promotion of Cleaners if the vacancies still remain then the posts should be filled in from qualified Ex-Servicemen only, provided the vehicles are on the Road.

- 4. The Trade Test/Driving Test should be taken before placing the cases before the Competent Selection Committee as stipulated in Clause 'e' of the Administrative Circular No.437 dated 14/10/2004.
- 5. Other pre-requisites regarding qualification, experience etc. prescribed for the post of Vehicle Driver shall remain unchanged.
- 6. This Administrative Circular comes into force with immediate effect.
