Sub:- Bombay Labour Welfare Fund Act 1953
 (BOM XL of 1953) - Payment of
 employees' and employer's contribution
 at revised rates.

Ref:- This office circular No. LIR/B/BLWF/3/
 32240 dt. 3-10-87.

The Govt. of Maharashtra, Industries, Energy and Labour Department vide Govt. Notification No. MLW 1992/(351)/LAB-12, dt. 22nd June, 1993 has increased the rates of contribution payable by the employees' and the employers' every six months under Sub-section (2) of Section 6 BB of the Bombay Labour Welfare Fund Act, 1953 (BOM XL of 1953).

The increased rates are effective from employees' and employers' contribution from six monthly period - payable as on 31st June, 1993 and every 31st Dec. and 30th June thereafter as under:-

All the field officers are requested to take note of the relevant changes of increased rate as notified and pay to Maharashtra Labour Welfare Board, the employees' and employers contribution at the revised rates for the six monthly period ending 30th June 1993 and onwards before the due dates specified in the Act. If the employees' contribution have already been recovered at the lesser old rate, the difference should be recovered immediately and paid to the Labour Welfare Board.
