CIRCULAR :

Sub: Staff Welfare Fund.

The first meeting of the Maharashtra State Electricity Board Staff Welfare Fund Committee was held in the T.M./C.E.(I)'s chamber on 4.10.74. The Committee has unanimously adopted following Resolutions:-

Resolution No. 1
Sons and Daughters A scheme of cash prizes and scholarship for the following terms and conditions:

Three cash prizes of Rs. 100/-, Rs. 75/- and Rs. 50/- each per year should be given to the sons and daughters of the Board's employees who have passed the last S.S.C. or equivalent examinations held in 1974 and pass thereafter with a minimum of 50% marks. 1st, 2nd and 3rd ranked persons amongst the sons and daughters of the employees in the regions of Western Maharashtra, Marathwada and Vidarbha would be eligible for these prizes.

b) The prizes will be separately awarded in the areas of the Western Maharashtra, Marathwada and Vidarbha.

Resolution No. 2.

In all 18 scholarships of the value of Rs. 25/- per month should be granted to the sons and daughters of the employees for one year beginning from the next academic session on the following basis :-

- a) Out of the 18 scholarships 12 will be awarded to the sons and daughters of Class IV employees and six to those of Class III employees.
- b) The scholarships will be equally divided in the regions of Western Maharashtra, Marathwada and Vidarbha.
- c) The scholarships will be paid to the students who are taking higher education after S.S.C. or equivalent examinations in Arts, Science, Medicines, Engineering or Military courses in the State of Maharashtra.
- d) These scholarships will be awarded after ranking the applicants on the basis of their marks obtained in the S.S.C. or equivalent examinations in the three Regions.

The Committee has also decided to utilise some amount to meet any individual representation for help received from the employees provided such requests fall within the welfare activities included in the Maharashtra State Electricity Board Staff Welfare Fund Regulations and Procedure and relate to the period on and from 1.4.74 and not earlier.
