Preamble:

 After Industrial Engineering study and submission of report thereof by M/s CRISIL, Norms for various field offices in MSEDCL were accepted by the Board of Directors MSEDCL vide B. R. No. 781 dtd 16/04/2009 and these Norms were circulated vide O. O. No. MPR-04 (GAD/CGM(TE)/MPR/Staff Norms/14664) dtd 16/05/2009.

 Consumer Norms were revised along with revision in earlier prescribed Variable Norms for Field Offices vide B. R. No. 1273 dtd 11/10/2010 and circulated vide O. O. No. MPR-29 (GAD/CGM(TE)/MPR/Staff Norms/33940 dtd 04/11/2010.

3) It is decided by the management of the Company to take review of sanction of all posts in HR Cadre and to modify it up to some extent for better utilization of manpower and for fair chances of promotion at every stage of hierarchy.
