## Preamble:

The "Disciplinary Action Module" in HRMS System is deployed on production from 01-01-2014 and instructions have issued to all the Authorities competent to initiate disciplinary actions to process all cases related to the Disciplinary Actions i. e. cases related to the S. Cases not processed through the "Disciplinary Action Module" and without authentic System Generated Number will be treated as fruitless. Instructions have also issued to enter the data of past DC cases within a period of one (01) year.

For performing this task within scheduled time limit, matter of giving some additional manpower to the Circles and Divisions in field is under consideration of the Management. Now, the Management has decided to create additional posts for completion of the above task in addition to the regular work as detailed below.

## Order:

In pursuance of the approval accorded by the Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Administrative Circular No. 1 dated 29/09/2005, following Orders are issued.

1) To create 42 additional temporary posts of Upper Division Clerk (HR) i.e. one each on the establishment of 42 O&M Circles for a period of one (01) year from the date of issue of this order as shown in Annexure "A".

2) To create 133 additional temporary posts of Lower Division Clerk (HR) i.e. one each on the establishment of 133 O&M Divisions for a period of one (01) year from the date of issue of this order as shown in Annexure "A"
