OFFICE ORDER MPR :- 02

Preamble:

After Industrial Engineering Study and submission reports thereof by M/s CRISIL, careful study of the same by the “Study Team” and after acceptance of the same by the Board of Directors MSEDCL, revised staffing norms were accepted and circulated vide Office Order No. 4 (GAD/CGM (T/E)/ MPR/Staff norms/14664) dt. 16/05/2009. Consumer as well as staff norms were again revised vide B.R. No. 1273 dtd. 11/10/2010 and circulated vide O.O. No. MPR- 29 (GAD/CGM (T/E)/MPR/ 33940) dtd. 04/11/2010. In the staff norms prescribed for various offices, new posts of Art “A” (Meter Reader/Operator), Art “B” (Meter Reader/Operator), Art “C” (Meter Reader/Operator), Driver (O/s) and Watchman (O/s) have been created. Zone wise sanction of these posts is as detailed in Annexure “A”.

Due to instructions issued while circulating these norms, MSEDCL is not utilizing this sanction of posts. However, overall sanction and vacancies of Manpower is unnecessarily increased by these posts. Data of Manpower/Vacancies is being required to utilize in various information/calculations in day to day work of MSEDCL as well as being submitted to Government/Non-Government Authorities. Considering this as well as other factors, Management of MSEDCL is under consideration of review of this sanction for some time past. Now, Management of MSEDCL has decided to make these posts non-operative and to be excluded from the total sanction of posts of all such establishments on which sanction of these posts appears.

ORDER

In pursuance of the approval accorded by the Managing Director MSEDCL in consultation with the Director (Finance), Director (Projects), Director (Operations) and in exercise of the powers delegated to him under Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd., following Orders are issued.

“To make Non-Operative the posts of Art “A” (Meter Reader/Operator), Art “B” (Meter Reader/Operator), Art “C” (Meter Reader/Operator), Driver (O/s) and Watchman (O/s) appeared in the sanctioned strength of various establishments in MSEDCL as detailed in Annexure “A” (total 9852 posts i.e. Departmental 4267 and O/s 5585 posts) and to be deleted from the sanctioned strength of MSEDCL.”
