Preamble:

After issue of office order under reference, there was request from V & S directorate for sanction of some additional posts and for specifications in nominclature/ H.Q. of V&S Offices. This issue was under consideration for some time and now the Competent Authority has accorded approval for the following.

Order:

In pursuance of the approval accorded by the Managing Director, MSEDCL, in consultation with the Director (Projects), Director (Operations) & Director (Finance) and in exercise of the powers delegated to him under Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. Employees' Service regulations, following Orders are issued.

- i) To create two (2) posts of **Office Assistant** (outsourced) on the establishment of Directorate V&S at Corporate level.
- ii) To fix Head Quarters of 3 Regional Offices at Kalyan, Pune and Nagpur and their nomincleture is as "Regional Office (V&S) Kalyan", "Regional Office (V&S) Pune" and "Regional Office (V&S) Nagpur" respectively
- iii) To create one (1) each post of **Office Assistant/ Typist** (outsourced) on the establishment of Regional Office (V&S) Kalyan, Regional Office (V&S) Pune and Regional Office (V&S) Nagpur.
- iv) To fix Head Quarter of Zonal (V&S) Office Bhandup at Kalyan instead of Bhandup and its nomincleture is as "Zonal (V&S) Kalyan".
- v) To attach Zone Offices for works as below:

- viii) To restore 1 post of Dy. Director (V&S) on the establishment of Regional V&S Offices and post of Supdtg. Engineer (Dist.) only if Dy. Director (V&S) is not available.
- ix) To restore nomenclature of the unit as "Flying Squad" instead of "Theft Detection Unit".

Accordingly, staff set up including above sanction for Directorate V&S at Corporate level and Regional (V&S) offices with nomenclature is as shown in Statement "A & B" respectively.
