OFFICE ORDER:- MPR- 28

Preamble:

Restructuring of Testing Divisions/ Sub Divisions, creations of New TQA Circles and new Testing Divisions along with creation of posts was ordered vide Office Order No. 29 (GAD/CGM (T/E)/MPR/35630) dt. 13/11/2009. Phased manner in which new offices will be started was ordered vide Office Order No. 30 (GAD/CGM(T/E)/MPR/ 35631) dt. 13/11/2009. Vide these orders, new "**Nagpur NZ Testing Division**" was created which will start functioning in third phase with effect from December 2010. It was under consideration of the Competent Authority for some time past to effect few changes in these orders keeping in view of smooth functioning, supervision and control. After careful examining the issue, Competent Authority has approved following.

Order:

In pursuance of the approval accorded by the Chairman & Managing Director, MSEDCL, in consultation with the Director (Operations), Director (Projects) and Director (Finance) and in exercise of the powers delegated to him under Schedule First appended to the Maharashtra State Electricity Distribution Company Limited Employees' Service Regulations, following Order is issued.

- i) To shift H.Q. of "Nagpur NZ Testing Division" from Nagpur to **Bhandara**.
- ii) To rename "Nagpur NZ Testing Division" as "**Bhandara Testing Division**".
- iii) To place administrative control of employees working under renamed **Bhandara Testing Division** and **Wardha Testing Sub Division** with Superintending Engineer Bhandara Circle instead of Superintending Engineer Wardha Circle.
- iv) To **merge** existing **Bhandara Testing Sub Division** in renamed **Bhandara Testing Division** along with posts as detailed in Statement "A".


