OFFICE ORDER:- MPR - 31

Preamble:

MSEDCL has handed over 03 Divisions from Nagpur "U" Circle to Franchisee, M/s SPANCO w. e. f. 01/05/2011. Due to this handing over, issue of reviewing the offices/establishments under this Circle along with review of sanctioned strength for those offices/establishments was under consideration of the management of Company some time past. Review of some offices have already been taken and Nagpur Urban Circle was converted in to "Nagpur Small Urban Circle (NSUC)", "Nagpur Nodal Team" was created by utilising posts from NUC Nagpur and remaining posts were declared as surplus vide Office Order No. MPR-05 (GAD/CGM (T/E)/MPR/16756) Dtd 31/05/2011.

Now, it is decided by the management of Company that following remaining offices/establishments along with sanctioned strength are to be abolished.

Order:

In pursuance of the approval accorded by the Chairman & Managing Director in consultation with the Director (Operations), Director (Projects) and Director (Finance) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Administrative Circular No. 1 dated 29/09/2005, following Orders are issued.

- i) To detach Congress Nagar Division, MIDC Division and Nagpur (U) Testing Division from the then Nagpur "U" Circle (NUC) and to attach them to Nagpur Small Urban Circle (NSUC) along with employees, offices, assets, liabilities etc. for all purposes.

- ii) To abolish Mahal Division, Civil Lines Division and Gandhibag Division along with offices there under.
- iii) To abolish 353 departmental & 53 O/s posts from the establishment of Mahal Division, 313 departmental & 45 O/s posts from the establishment of Civil Lines Division, 257 departmental & 37 O/s posts from the establishment of Gandhibag Division and 01 Testing Batch along with 05 departmental posts from Nagpur (U) Testing Division as detailed in appended statement "A".
- iv) To abolish Audit Inspection Unit Nagpur (U) & Legal Unit attached to NUC Nagpur.
- v) To continue Nagpur "U" Flying Squad Unit as hither to before.
