Preamble:

During the process of review of manpower, possibilities of curtailment of posts as well as additions of posts in some sections/areas of Corporate Office Mumbai according to the workload have been explored and Management of Company has decided to reshuffle the sanction of posts as per requirement along with declaring some posts as surplus.

Order:
