OFFICE ORDER MPR:-39/2013

Board of Director's MSEDCL has accepted revised staffing norms vide B. R. No. 781 Dtd.16-04-2009 and these norms were circulated vide O.O.No. MPR - 04 (GAD/CGM(TE)/MPR/14664) Dtd.16-05-2009. As per these Norms, posts of "Jr. Technician (Os)" have been provided for Urban Section Offices and for Section Offices in Corporation areas in view of definition of Corporations/ Urban and Rural S/Dn. provided in Para no.11 of the said order.

However, it has come to the notice that, in some Circles/Divisions under KLNZ Kalyan, erroneous sanction of the posts of Sr. Technician and Jr. Technician have notified by applying wrong Norms, i.e. by applying Norms of Urban Sections though these sections are not covered in the definition of Urban Sections as they are situated outside the concerned Municipal Jurisdiction.

It is decided to review and rectify such erroneous sanction of posts.

Order

In pursuance of the approval accorded by the Chairman & Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Administrative Circular No.1 dated.29/09/2005, following Orders are issued.

- 1) To abolish in principal 17 Departmental posts of Sr. Technician from various establishments under KLNZ Kalyan as shown in Statement
- 2) To abolish in principal 56 Departmental posts + 68 OS posts of Jr. Technician from various establishments under KLNZ Kalyan as shown in Statement "A-2".
- 3) To create in principal 20 Departmental Posts of Jr. Technician on various establishments of KLNZ Kalyan.
- 4) To authorize C. E. KLNZ Kalyan to notify revised sanction as done earlier.
