OFFICE ORDER: MPR-04/2012

PREAMBLE:

After accepting report on Industrial Engineering Study submitted by M/s CRISIL on the issue of revised norms and Staff Set – up, MSEDCL has decided to discontinue some posts which where exist in earlier Staff Set-up vide B. R. No. 781 dtd 16/04/2009. Out of these discontinued posts, posts of Line Foreman, Meter Tester Gr–I, Meter Tester Grade–II, Vehicle Cleaner and Watchman have been discontinued and these posts are not prescribed/included in revised Staff Set-up of any office. This decision has been continued during acceptance of revised consumers as well as Staffing norms vide B. R. No. 1273 Dtd. 11/10/2010.

However, during verification of sanction of posts for various offices, it is seen that, few posts with these nomenclatures still exist as sanctioned. Now it is decided to re-define/abolish these posts.

ORDER:

In pursuance of the approval accorded by the Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Administrative Circular No. 1 dated 29/09/2005, following Orders are issued.

- 1. To re-define posts of Line Foremen/Art 'A' (Electrician) appearing on the sanctioned strength of Amravati, Aurangabd and Sangli Training Centers as Art 'A' (Electrician).
- 2. To abolish one vacant post of Meter Tester Gr I from sanctioned strength of Bhiwandi Nodal Office.
- 3. To abolish one post of Meter Tester Gr II from sanctioned strength of Thane III Division (Mumbra Shil Div.).
- 4. To abolish two posts of Vehicle Cleaner/Helper from sanctioned strength of T & S Eklahare, Nasik.
- To abolish 201 posts of Watchman from sanctioned strength of 09 Major Stores and 20 Stores Centers as detailed in Annexure "A".
