OFFICE ORDER: MPR - 42/2019

The Board of Directors, MSEDCL vide their Resolution No. 439 dtd. 06/07/2015 have accorded approval to create 623 new sub stations along with the posts of Operating Staff on the establishment of newly commissioned/ commissioning sub stations during the period 2014-15 under RAPDRP and Infra Scheme. Subsequently, Office Order of the above 623 sub stations was issued vide MPR-17/2015 dtd. 15/07/2015.
