OFFICE ORDER: MPR - 45/2012

Preamble:

Revised staffing norms were circulated vide Office Order No. 4 (GAD/CGM (T/E)/MPR/Staff norms/ 14664) dt. 16/05/2009 and vide O.O. No. MPR- 29 (GAD/CGM (T/E)/MPR/33940) dtd. 04/11/2010. In the staff norms prescribed for Division offices, new Department/Unit as Flying Squad was introduced.

It is expected to perform following functions by the incumbents working in this unit.

- 1) Regular checking of Consumer premises meters & Theft detection, Monitoring theft drives at S/D level, Energy Audit.
- 2) H. T. Connection Billing & Correspondence.
- 3) Any other jobs assigned by the superiors

Subsequently, after restructuring, Flying Squads under V. & S. Dept. have been provided two teams instead of one team and sanctioned posts to these squads were also increased. As such, job assigned to the Flying Squads in Division Offices is being done by the Flying Squads under V. & S. Dept.

It is also experienced that, services of the incumbents working in the Flying Squads in Division Offices are not utilised for the purpose for which these squads were created.


It is decided to review and rectify sanction of these posts.

- 2) **To abolish 132 posts of Jr. Engineer (Dist) and 132 posts of Jr. Technicians created for these units w.e.f. 01-08-2012 as shown in appended Statement "A".**
- 3) **To continue 132 posts of Chief Technician in the Roving Gang of the respective Division Offices w.e.f. 01-08-2012 as shown in appended Statement "A".**
