OFFICE ORDER MPR :- 46/2013

Preamble:

After Industrial Engineering study and submission of report thereof by M/s CRISIL, Norms for various field offices were accepted by the Board of MSEDCL vide B.R.No. 781 dtd. 16-04-2009 and circulated vide O. O. No. MPR - 04 (GAD/CGM(T/E)/MPR/14664) dtd. 16-05-2009. However, during these process consumers' norms as approved in B.R.478 dtd.23/02/2005 were kept in force. The consumer norms were revised and changed besides revising variable norms for field offices vide B.R. No 273 dtd.11/10/2010. These norms were circulated vide O. O. No. MPR-29 (GAD/CGM (TE)/MPR/Staff Norms/33940) dtd. 04/11/2010.

As per revised norms, the condition of "50% of Rural Section offices shall be headed by the Sub Engineers (Dist) and balanced 50% shall be by the Junior Engineers to be decided by the Zonal Chief Engineers depending upon local priorities and requirements"


However, it is found that Jr. Engineers are posted against the sanctioned posts of Sub Engineer and vice versa in KOPZ Kolhapur. Therefore, it is decided to set right the sanctioned positions of these posts by rectifying erroneous sanction.

Order:

In pursuance of the approval accorded by the Chairman & Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Adm. Circular No. 01 dtd. 29/09/2005, the following Order is issued.

- 1) **To create 29 posts of Jr. Engineer (Dist) with abolition of 29 posts of Sub Engineer Dist) on the establishment of 29 section offices under KOPZ Kolhapur as shown in the Statement "A-A".**
- 2) **To create 46 posts of Sub Engineer (Dist) with abolition of 46 posts of Jr. Engineer(Dist) on the establishment of 46 section offices under KOPZ Kolhapur as shown in Statement "A-B"**
