
1) The Board vide their Resolution No. 525 dtd. 14/10/2015 have accorded approval for.

2) In pursuance of the approval accorded by the Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him under the powers delegated to him vide Schedule First Sr No. "A+B" & "F" appended to the Maharashtra State Electricity Distribution Co. Ltd., following Orders are issued.

- 1) **To close 06 Departmental pole factories located at Perne, Dondaicha, Murud, Jalna, Gangakhed & Yavatmal.**
- 2) **To run existing 10 Departmental pole factories, located at Pandharpur, Satara, Jaisingpur, Jalgaon, Satpur, Rahuri, Beed, Narsi, Washim & Warora on partial turnkey basis through private vendors.**
- 3) **To create one new Pole factory in kokan region at Sale -Mangaon (Statement-A)**
- 4) **To create new Civil Circle Office at Aurangabad. (Statement- B)**
- 5) **To create 15 Departmental posts & 04 Outsource posts on the establishment of newly created Civil Circle at Aurangabad & to create 01 Departmental post on the establishment of newly created pole factory at Sale-Mangaon by utilizing the surrendered existing surplus posts at Sr. No. 1 & 2.**
- 6) **To upgrade 10 Civil Sub Division presently headed by Dy. Executive Engineer (Civil) into Addl. Executive Engineer (Civil) viz. Satara, Solapur, Ahmednagar, Nashik, Chandrapur, Vasai, Sangli, Vashi, Latur & Pimpri.**

- 7) To create one each post of Addl. Ex. Engineer (Civil) at existing three Civil Circle at Kalyan, Pune, Nagpur & one new Civil Circle at Aurangabad by utilizing the surrendered existing surplus posts at Sr. No. 1 & 2.
- 8) To Create one each post of Assistant Engineer (C) having vast jurisdiction & heavy work load at Vasai, Vashi, Ahmednagar, Solapur, Kolhapur, Jalgaon, Amravati, Nanded, Dadar & Pen (10 nos.) by utilizing the surrendered existing surplus posts at Sr. No. 1 & 2.
- 9) To detach Jalgaon Civil Division, Latur Civil Division and Nanded Civil Division from Pune Civil Circle & to attach newly created Aurangabad Civil Circle
- 10) To detach Aurangabad Civil Division from Nagpur Civil Circle and to attach to the newly created Aurangabad Civil Circle.
- 11) To detach Nashik Civil Division from Pune Civil Circle and to attach to Kalyan Civil Circle.
