OFFICE ORDER: MPR - 55/2012

Preamble:

Board of Directors MSEDCL has accepted revised staffing norms vide B. R. No. 781 dtd. 16-04-2009 and these norms were circulated vide O. O. No. MPR - 04 (GAD/CGM(T/E)/MPR/14664) dtd. 16-05-2009. As per these Norms, posts of "Jr. Technician (OS)" have been provided for Urban Section Offices and for Section Offices in Corporation areas only. Clarifications regarding Corporations/Urban and Rural S/Dn. have been given in Para no. 11 of this order.

However, it came to the notice that, in some Circles/Divisions under Jalgaon Zone, erroneous sanction of the posts of Sr. Technician and Jr. Technician have been notified by applying wrong Norms i. e. by applying Norms of Urban Sections though these sections are not covered in the definition of Urban Sections as they are situated outside the concerned Municipal Jurisdiction.


It is decided to review and rectify such erroneous sanction of posts.

Order:

In pursuance of the approval accorded by the Chairman & Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Adm. Circular No. 01 dtd. 29/09/2005, following Order is issued.

- 1) To abolish in principle 37 Departmental posts of Sr. Technician from various establishments under JLGZ Jalgaon as shown in Statement "A-1".**
- 2) To abolish in principle 12 Departmental posts + 148 OS posts of Jr. Technician from various establishments under JLGZ Jalgaon as shown in Statement "A-2".**
- 3) To create in principle 38 Departmental Posts of Jr. Technician on various establishments of JLGZ Jalgaon.**
- 4) To authorize C. E. JLGZ Jalgaon to notify revised sanction as done earlier.**
