Posts of Jr. Operator and Jr. Technician will be initially filled in by engaging candidates as **Upkendra Sahayyak** & **Vidyut Sahayyak** on fixed remuneration on contractual basis for a period of 03 years and on satisfactory completion of contractual period will be absorbed in the regular posts.

Considering the above, it is now decided to change the above referred Norms and to convert the Outsourced sanctioned posts of Jr. Operator & Jr. Technician as Departmental Sanction.

Further in every Division in 50% of Sub Stations, 4th Operator would be Asstt. Operator (Art "B") & in 50% Sub Stations, would be Dy. Operator (Art "A").
