OFFICE ORDER: MPR - 84 /2013

Preamble:

- Revised pattern for "U" Divisions including Sub Divisions & Section Offices there under (Pilot Project) has been implemented in Kolhapur "U" Division vide O. O. No. MPR-16 (HR/CGM (HR-TE)/MPR/6537) dtd 15-03-2012 read with O. O. No. MPR-17 (HR/CGM (HR-TE)/MPR/7787) dtd 28-03-2012 & O. O. No. MPR-19 (HR/CGM (HR-TE)/MPR/8698) dtd 03-04-2012.
- 2. The Pilot Project has been implimented in Sangli "U" Division vide O. O. No. MPR-78 (HR/CGM (HR-TE)/MPR/30226) dtd 23-10-2012.
- 3. To compensate the financial burden of hired vehicles to be engaged for this restructuring, 43 posts of Technicians from these establishments were declared as abolished vide O. O. No. MPR-89/2013 (HR/CGM (HR-T/E)/ MPR/35546) dtd 24-12-2012.
- 4. However, as notified vide O. Ö. No. MPR-53/2013 (HR/CGM (HR-T/E)/MPR/15762) dtd 04-06-2013, the Chief Engineer KOPZ, Kolhapur has informed that, Pilot Project for "U" Sub Divisions in following offices under his control has been stopped/not implemented and also requested to revive the abolished posts of **Technicians**.
- 5. Considering the stoppage of Pilot Project, it is decided to revive the posts of Technicians.

ORDER:

In pursuance of the approval accorded by the Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Administrative Circular No. 1 dated 29/09/2005, following Orders are issued.

1) To revive one each post of Technician on the establishments of following Fourty Three (43) Section Offices under KOPZ, Kolhapur (earlier abolished vide O. O. No. MPR-89/2013 (HR/CGM(T/E)/MPR/35546) dtd 24-12-2012)
