OFFICE ORDER: MPR - 87/2013

Preamble:

1. Revised pattern for "U" Divisions including Sub Divisions & Section Offices there under (Pilot Project) has been implemented in Ahmadnagar "U" Division vide O. O. No. MPR-16 (HR/CGM (HR-TE)/MPR/6537) dtd 15-03-2012. It has been implimentated in Malegaon UCR Division, Nashik "U" Division-I and Nashik "U" Division-II vide O. O. No. MPR-78 (HR/CGM (HR-TE)/MPR/30226) dtd 23-10-2012.
2. **To compensate the financial burden of hired vehicles to be engaged for this restructuring, 63 posts of Technicians and 52 posts of Jr. Technicians (OS) from these establishments were declared as abolished vide O. O. No. MPR-89/2013 (HR/CGM (HR-T/E)/MPR/35546) dtd 24-12-2012.**
3. However, as notified vide O. O. No. MPR-53/2013 (HR/CGM (HR-T/E)/MPR/15762) dtd 04-06-2013, the Chief Engineer NSKZ, Nashik has informed that, Pilot Project for "U" Sub Divisions in following offices under his control has been stopped/not implemented and also requested to revive the abolished posts of **Technicians and Junior Technicians (Outsource).**
4. Considering the non implementation of Pilot Project, it is decided to revive the posts.

ORDER:

In pursuance of the approval accorded by the Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Administrative Circular No. 1 dated 29/09/2005, following Orders are issued.
