OFFICE ORDER: MPR-92/2012

In pursuance of the approval accorded by the Managing Director, MSEDCL, in consultation with the Director (Finance), Director (Operations) and Director (Projects) under the powers delegated to him vide Schedule First appended to the Maharashtra State Electricity Distribution Co. Ltd. read with Administrative Circular No. 1 dated 29/09/2005 and in partial modification of O. O. No. MPR-78 (HR/CGM (HR-TE)/MPR/30226) dtd 23-10-2012, following Orders are issued.

- 1) To create one (01) post of Junior Engineer (Dist) on the establishment of Nerul Sub Division by abolition of the 03 posts of Jr. Technician diverted in to Common Pool of the said Sub Division.
