2. To change the existing nomenclature of the posts belonging to GAD Cadre without any change in present pay scales and status attached to the said posts as under :-

2. Consequently,


- I) The word General Administration Department / GAD Cadre wherever appeared in Classification and Recruitment Regulations 2005, MSEDCL Employees' Service Regulations 2005 & MSEDCL Employees' Seniority Regulations 2005 shall stand replaced as Human Resource Department/HR Cadre.
- II) The present nomenclature of the posts in GAD cadre wherever appeared in the Classification and Recruitment Regulations 2005, MSEDCL Employees' Service Regulations 2005, MSEDCL Employees' Seniority Regulations 2005 shall stand replaced as shown above.

3. If there is more than one incumbent holding the same post in the same office, the new nomenclature shall be known according to the main functions carried out by the incumbent and the same shall be indicated in the bracket so as to facilitate specific identification.

For example:-

- (i) Chief General Manager(HR-TE)
- (ii) General Manager(HR-DC)
- (iii) Manager(HR-O&M)
- (iv) Manager(HR-RC)
- (v) Manager(HR-NTE) etc.
