
The Board of Directors has accorded approval for revising the pre-requisites for the post of Operator appearing under Pay Group III – Technical Posts (Sr.No.16) and for the post of Technician appearing under Pay Group IV – Technical Posts (Sr.No.2) of Schedule A-1 appended to Classification and Recruitment Regulations, 2005 vide Board Resolution No.646 dated 11/03/2016. The pre-requisites for the posts will be as below now onwards:

**Operator**

- (i) **Educational Qualification:** Secondary School Certificate Examination conducted by Maharashtra State Board of Secondary & Higher Secondary Education (MSBSHSE) under 10+2 pattern or its equivalent and ITI in Electrician/Wireman Trade/COE (Electrical Sector)/2 years Diploma (Electrician/Wireman) **AND** National Apprenticeship Certificate in Electrician/Wireman Trade or Center of Excellence (Electrical Sector) awarded by the National Council for Training in Vocational Trade (NCTVT), New Delhi given on completion of National Apprenticeship under the Apprenticeship Act, 1961.
- (ii) **Experience :** 2 years experience after completion of National Apprenticeship in Electrician/Wireman Trade under the Apprenticeship Act, 1961 in the Power Sector.

**Technician**

- (i) **Educational Qualification:** Secondary School Certificate (SSC) Examination conducted by Maharashtra State Board of Secondary & Higher Secondary Education (MSBSHSE) under 10+2 pattern or its equivalent **AND** National Trade Certificate in Electrical / Wireman trade on completion of the ITI Trade Course **OR** Centre of Excellence (Electrical Sector) awarded by the NCTVT, New Delhi / 2 years Diploma (Electrician/Wireman) awarded by the Maharashtra State Board of Vocational Examination.
- (ii) **Experience:** No previous years experience is necessary.
2. The Board further resolved that 10% reservation be provided to the candidates who have undergone apprenticeship training in the MSEB or any of the power utility under MSEBHCL in Electrician/Wireman Trade.
3. The revised provisions shall be come into force from the date of issue of Board Resolution i.e. 11<sup>th</sup> March 2016.
