CORRECTION SLIP NO. 17 DATE 14/07/2011 (To MSEDCL Employees' Service Regulations 2005)

Sub: Introduction of Surety Bond on initial appointment under Direct Recruitment.

In exercise of the powers delegated to him vide Adm.Cir.No.1 dated 29/09/2005, the Managing Director in consultation with the Director(Projects), Director(Operations) and Director(Finance) has accorded approval to introduce Surety Bond for a period of three years on initial appointment in Pay Group I, II & III (State Seniority Group) category in the Company and in case of the resignation tendered by the employee during **Bond Period**, the employee will have to repay to the Company an amount as prescribed below.

- 2. Consequently the above provisions shall be added to the MSEDCL Employees' Service Regulations, 2005 as under:-
 - (a) Regulation No. 11(e): All appointments under direct recruitment on first instance for Pay Gr. I, II & III (State Seniority Group) shall be made by executing and obtaining Surety Bond annexed herewith as ANNEXURE-'A', for serving in the MSEDCL for a period of three years. The amount of Surety Bond for Pay Gr. I, II & III shall be as under:

Pay Gr. I - Rs.1,00,000/Pay Gr. II - Rs. 75,000/Pay Gr. III - Rs. 50,000/(State Seniority Group)

- (b) Regulation No.16(a): The existing Regulation No.16 shall be read as Regulation No.16(a).
- (c) <u>Regulation No.16(b)</u>: In the case of an employee who has been appointed under Direct Recruitment on first instance shall not quit the service of the Company within a period of three years unless he repays an amount shown in Regulation No. 11(e) to the Company, in addition to the provisions of Regulation No.16(a) above.
- 3. This Correction Slip shall come into force with immediate effect.
- 4. This Correction Slip is available on the Company's Intranet.
