SR. NO.	NAME OF POST	REVISED METHOD OF FILLING
1.	Regional Director/ Executive Director	i. By way of deputation for a period of three years. ii. As per requirement of the Company and after review of performance, the period of deputation may be extended by one year or till superannuation; whichever is earlier. iii. The recruitment process shall be carried out by the MSEB Holding Company Ltd. ("MSEBHCL")
