**Sub:-** Providing Mobile (GSM) Services to MSEDCL Employees, with Voice & Data Services in Maharashtra State (Including Mumbai).

On approval of competent authority, Letter of Intent for above subject services has been awarded to M/s Vodafone Mobile Services Ltd (New entity - M/s Vodafone Idea Ltd) , who is current service provider to MSEDCL.

The following data tariff plans has been offered and finalized.

- Above mentioned Data Plans should offer Roll – Over Data Benefits on monthly basis to a maximum of 25 GB.
- Throttling (2G/3G) offered free of charge, post consumption of subscribed data.
- Incoming Roaming & Outgoing Roaming Services should be free of charge on Pan INDIA basis.
- Miss call Alerts and caller tunes should be provided to all connections free of cost and should not proposed cost as VAS.
- No pay go charges (like 10 kb per paisa) should be applied to any connection within contract period.

As per administrative circular No 334 dated 01/04/2011 and subsequent amendments, Mobile services policy has been implemented to MSEDCL employees and financial usage limit per month for category of employees is mentioned in the circular.

Respective HOD of Divisions /Circles/Zones/Regional offices /Corporate office/Training centers need to submit/mail the list of mobile numbers operating under their jurisdiction mentioning the tariff plans from above tariff rental table to be activated. 

On configuration of above plans, services will be roll out , M/s Vodafone is migrating all company operated company paid (COCP) mobile numbers to the new tariff plan on receipt of the details received by respective HODs. The migration will be effected during month of September – October 2018.

After change of plan and migration of tariff plan, the first bill will be issued on pro-rata basis (considering both old and new tariff plan) as per billing cycle patterns, however second bill should be generated as per new tariff plan.

Any deviation to applicability of tariff plan to category of officers/employees mentioned in the above tariff rental table, Chief Engineer (Civil) is the competent authority and prior approval should be obtained.
