The clarification / guidelines regarding implementation of General Transfer Policy have been issued from time to time.

- Considering the general transfer activity in past few years, it is observed that, the last date of issuing transfer orders is between 15th to 30th June and accordingly some of the employees join at the place of posting in the month of July. Subsequently, some of these employees fall short of two year tenure period by 30 to 45 days when considering their request transfers. In the light of the above, various unions have requested to consider the tenure of employees / officers for request transfers as on 15th July 2019 instead of 31st May 2019.
- Now it is decided to extend the tenure date as on 15th July 2019 for considering request transfers for the current year 2019 instead of 31st May 2019. However, the request transfer applications existing in the HRMS system as on 31st May 2019 will only be considered.
- All concerned Authorities are requested to implement the transfers as per clarification / guidelines issued from time to time.
