Sub: Implementation/ non implementation of the Restructuring of Sub Divisions & revival of abolished posts.

- Revised pattern for "U" Divisions including Sub Divisions & Section Offices there under (Pilot Project) has been implemented initially in 06 selected "U" Divisions from 01-05-2012 enlisted in appended statement vide O. O. No. MPR-16 (HR/CGM (HR-TE)/MPR/6537) dtd 15-03-2012 read with O. O. No. MPR-17 (HR/CGM (HR-TE)/MPR/7787) dtd 28-03-2012 & O. O. No. MPR-19 (HR/CGM (HR-TE)/MPR/8698) dtd 03-04-2012.
- 2. The Pilot Project has been implimented in Beed "U" Sub Division from 01-10-2012 vide O. O. No. MPR-54 (HR/CGM (HR-TE)/MPR/24002) dtd 24-08-2012.
- The Pilot Project has been implimented in 30 Divisions from 01-11-2012 vide O.
   No. MPR-78 (HR/CGM (HR-TE)/MPR/30226) dtd 23-10-2012.
- 4. This restructuring has been continued beyond experimental period in the Sub Divisions/Sections where it was introduced vide orders referred in sr. no. 1, 2 & 3 vide O. O. MPR-83 (HR/ CGM (TE)/MPR/32422) dtd 21-11-2012.
- 5. To compensate the financial burden of hired vehicles to be engaged for this restructuring, 434 (342+92) posts of Technicians from the establishments of 97 (79+18) Sub Divisions and 272 posts of Jr. Technicians (OS) from the establishments of 272 Section Offices were declared as abolished vide O. O. No. MPR-89/2013 (HR/CGM (HR-T/E)/MPR/35546) dtd 24-12-2012.

- 6. However, after considering the difficulties expressed by the Chief Engineers of some Zones in implementing this restructuring, Competent Authority has reviewed earlier decisions and now concerned Chief Engineers have been authorized to start or to continue or to discontinue this restructuring of offices. This decision was notified vide O. O. No. MPR-53/2013 (HR/CGM (HR-T/E)/MPR/15762) dtd 04-06-2013.
- 7. Chief Engineer JLGNZ Jalgaon has requested to restore these abolished posts simply by raising one Template.
- 8. However, as the decision of the abolition of these posts has been taken by the Competent Authority, for revival of these posts, proposal needs to be processed to the competent Authority only.
- 9. As such, all Chief Engineers are requested to submit one consolidated proposal for Zone as a whole for revival of such posts, if they desire, covering abolished posts as per O. O. No. MPR-89/2013 with following details.
  - 9.a) Names of offices where Pilot Project & restructuring has been implemented/ started and continued permanently along with actual dates of implementation.
  - 9.b) Names of offices where Pilot Project & restructuring has not at all been implemented/started and not willing to implement in future.
  - 9.c) Names of offices where Pilot Project & restructuring has been implemented/ started and now discontinued along with actual dates of implementation & discontinuation.
  - 9.d) No. of posts proposed for revival.
- 10) After receipt of such proposals, the same will be processed to the Competent Authority for approval & decision will be conveyed in due course.
- 11) This is issued with the approval of the Executive Director (HR).
