**Easing of Restrictions and Phase-wise opening of Lockdown. (MISSION BEGIN AGAIN)**

Whereas, in exercise of the powers, conferred under the Disaster Management Act 2005, the undersigned, in his capacity as Chairperson, State Executive Committee has issued an Order dated 30<sup>th</sup> September, 2020 and 14<sup>th</sup> October, 2020 for containment of COVID-19 in the State, for a period upto 31<sup>st</sup> October, 2020, which was further extended for a period upto 30<sup>th</sup> November, 2020 and issued revised consolidated guidelines by including certain activities mentioned in Annexure II of the guidelines Order dated 14<sup>th</sup> October, 2020 from time to time vide above mentioned orders.

Whereas the State Government is satisfied that the State of Maharashtra is threatened with the spread of COVID-19 virus, and therefore to take certain emergency measures to prevent and contain the spread of virus, the Government in exercise of the powers conferred under Section 2 of the Epidemic Diseases Act, 1897, read with all other enabling provisions

of The Disaster Management Act, 2005, it is expedient to extend the lockdown in the entire State of Maharashtra further till midnight of 31<sup>st</sup> December, 2020.

Now, therefore, in exercise of the powers conferred under Section 2 of the Epidemic Diseases Act, 1897 and the powers conferred under The Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, hereby issues directions that the guidelines issued vide orders dated 30<sup>th</sup> September, 2020 and 14<sup>th</sup> October, 2020 to operationalize MISSION BEGIN AGAIN for easing of restrictions and phase-wise opening, will remain in force till 31<sup>st</sup> December, 2020 for containment of COVID-19 epidemic in the State and all Departments of Government of Maharashtra shall strictly implement these guidelines. The activities already allowed and permitted from time to time shall be continued and all earlier orders shall be aligned with this order and shall remain in force up to 31<sup>st</sup> December, 2020.
