**ADMINISTRATIVE CIRCULAR NO. 22 DATE 1/3/2006**

Sub : Change in the nomenclature of the existing posts of Chief Accounts Officer in Corporate Office of MSEDCL.

Consequent upon restructuring of the erstwhile MSEB, the nomenclature of some of the posts in Personnel Department has been changed as C.G.M.(P), G.M.(P) etc. with the same powers and authority of their respective posts in erstwhile MSEB.

2. On the same lines, a proposal to change the existing nomenclature of the posts of C.A.O. in Corporate Office was under consideration so as to maintain the equivalency of the posts of same status.

3. Now, in exercise of the powers delegated vide Adm.Cir.No.1 dated 29/9/2005, the Managing Director(MSEDCL) in consultation with Director(Financ) has accorded approval to change the existing nomenclature of the posts of Chief Accounts Officer in Corporate Office. Accordingly, the revised nomenclature of the posts of *Chief Accounts Officer in Corporate Office of MSEDCL* in English and Marathi shall be as under :-
