"Revised Meter Reading System" has been started initially in 14 Urban Divisions and then in Parbhani Circle and Hingoli Circle and also in Kannad Division vide office orders under reference. For smooth running of this system, one additional post of Jr. Manager (F&A) has been created for these offices. It was already instructed vide these orders that, the Billing staff of the Division/Sub-Division shall be under the control of Jr. Manager (F&A-M.R.).

However, it is noticed that, U.D.Cs. (A/c) working in Sub Divisions of these offices have not been directed to work under the control of Jr. Manager (F&A-M.R.) in the Revised Meter Resding System and still they are working under the control of Assistant Accountant/SDO. In result, though the work of meter reading is centralized, excess manpower is with Sub Divisions and shortage of manpower with Jr. Manager (F&A-M.R.).

Considering this, it is once again directed to follow the directives given in above office orders scrupulously and strengthen the Revised Meter System by providing manpower, which will give better results and enhancement in revenue of MSEDCL.
