Resolution 2370: The Board considered the proposal regarding adoption of the provisions of revised Reservation of Divyang Personnel (PHP) in the Company.

- 2. The Board took note of the following:
  - a) In 2016, Maharashtra Government allowed 3% reservation to Divyang people.
  - b) In light of the decision of the Central Govt. of India the State of Maharashtra has now 4% reservation for Divyang reservation is allowed for promotion to Pay Group 1 & 2.

- e) Disability Certificate as per guidelines issued by Government on dated 14/09/2019
- f) The Roster point maintaining with point no. 1, 26, 51 & 76
- g) If PHP not available then Zone of consideration 1: 5 & PHP reservation can be rotated.
- h) Unfilled posts to be carry forward for 3 years
