ORDER

Easing of Restrictions and Phase-wise opening of Lockdown. (MISSION BEGIN AGAIN)

Reference:

- 4) Ministry of Home Affairs (MHA) Order No. 40-3/2020-DM-1 (A) Dated 1st May 2020, 11th May 2020, 17th May 2020, 20th May 2020, 30th May 2020, 29th June 2020, 29th July 2020, 29th August 2020, 30th September 2020, 27th October 2020, 25th November 2020 and 28th December 2020.

Whereas, in exercise of the powers, conferred under the Disaster Management Act 2005, the undersigned, in his capacity as Chairperson, State Executive Committee has issued an Order dated 30th September, 2020 and 14th October, 2020 (extended by order dated 29th October, 2020 and 27th November, 2020) for containment of COVID-19 in the State, for a period upto 31st December, 2020 and issued revised guidelines by including certain activities from time to time vide above mentioned orders.

Whereas the State Government is satisfied that the State of Maharashtra is threatened with the spread of COVID-19 virus, and therefore to take certain emergency measures to prevent and contain the spread of virus, the Government in exercise of the powers conferred under Section 2 of the Epidemic Diseases Act, 1897, read with all other enabling provisions

of The Disaster Management Act, 2005, it is expedient to extend the lockdown in the entire State of Maharashtra further till 31st January, 2021.

Now, therefore, in exercise of the powers conferred under Section 2 of the Epidemic Diseases Act, 1897 and the powers conferred under The Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, hereby issues directions that the guidelines issued vide orders dated 30th September, 2020 and 14th October, 2020 (extended by order dated 29th October, 2020 and 27th November, 2020) to operationalize MISSION BEGIN AGAIN for easing of restrictions and phase-wise opening, will remain in force till 31st January, 2021 for containment of COVID-19 epidemic in the State and all Departments of Government of Maharashtra shall strictly implement these guidelines. The activities already allowed and permitted from time to time shall be continued and all earlier orders shall be aligned with this order and shall remain in force up to 31st January, 2021.
