The clarification / guidelines regarding implementation of General Transfer Policy have been issued from time to time. Due to administrative reasons, the date of promulgation of General Transfer Orders was extended up to 06th July 2019 for field offices and accordingly the last date for relieving the transferees was postponed up to 15th July 2019.

2. It is observed that, many transferees, after having been relieved, approach transferring authorities for modification or cancellation of their transfers and have not joined new place of duty on transfer. The Competent Authority has taken serious note of this and has directed to initiate STERN disciplinary action against the defaulters. The Competent Authorities as per Schedule 'C' appended MSEDCL Employees' Service Regulation-2005 hereby are directed to initiate disciplinary action as deemed fit against all the defaulters who did not join at their new duty postings. Further, the excess joining time availed should be treated as Extra Ordinary Leave according to Regulation No. 46 of MSEDCL, Employees' Service Regulation-2005. For necessary and immediate compliance please.
