Sub: Details of the sanctioned posts of Jr. Technician

Board of Directors MSEDCL has accepted revised staffing norms vide B. R. No. 781 dtd 16/04/2009 and circulated vide Office Order No. 4 (GAD/CGM (T/E)/MPR/Staff norms/14664) dt. 16/05/2009. Consumer as well as staff norms were again revised vide B. R. No. 1273 dtd. 11/10/2010 and circulated vide O. O. No. MPR - 29 (GAD/CGM(T/E)/MPR/33940) dtd. 04/11/2010. Variable Norms for the post of Jr. Technician prescribed by these orders are as shown in Annexure "A".

However, it is observed that, because of non giving specific directives, all Zone Offices have clubbed together the sanction of posts as per prescribed norms & posts sanctioned on the basis of variable norms & shown as total sanction of the post of Jr. Technician. It is not possible at the level of Corporate Office to segregate this sanction.

It is further observed that, though Variable Norms shown in above Office Orders are indicative as eligible criteria for additional posts to cope up the work load, some offices have under impression that, it is the blanket approval for additional sanction of posts & they have increased sanction of posts of their offices at their own accord without proper approval of Competent Authority for creation of posts.

In fact, it was expected that Zone Offices should initiate proposals for additional sanction of posts considering increase in consumers on the basis of Variable Norms. However, no such proposal based on Variable Norms is received during last two years.

Considering above, the Executive Director (HR) has directed to collect information regarding sanction of the posts of Jr. Technician. Information in format appended as Annexure "B" should be submitted Division-wise & duly consolidated at Zone level and to be submitted to Corporate Office, Zone as a whole. Division & Circle Offices shall not submit their information directly to Corporate Office.

It is further directed that, instances of increase in sanction of the posts of Jr. Technician considering the Variable Norms done by field Offices at their own accord without specific sanction Competent Authority should be verified & proposals for post facto approval are to be initiated immediately.

Information in enclosed format should reach to this office on or before 31/10/2011 & proposals if any should reach up to end of Nov. 2011.
