U.D.C.(GAD)/Acctts.)

Passing of MS-CIT Examination is made compulsory to the U.D.C.(GAD/Acctts.) promoted during 2009-10, to make them well equipped with the knowledge of Computer. Further, the instructions to revert those U.D.C.(GAD/Acctts.) who do not qualify the MS-CIT examination on or before 30/06/2010 were issued vide letter No.E.D.HR/Circular/34776 dt.04/11/2009 read with E.D.HR/Circular/34983 dt.05/11/2009. The time limit of passing the MS-CIT examination has been extended upto 31/12/2010 vide letter No. GAD/O&M/F.No.1/20805 dt.30/06/2010. However, it has been brought to the notice that some of the UDC(GAD/Acctts.) have not passed the said examination till today. Therefore, the issue of extending the time limit of passing the MS-CIT examination was under consideration.

2. Now, the Competent Authority has decided to extend the time limit for passing the MS-CIT examination upto **31/12/2011**. As such, those U.D.C.(GAD/Acctts.), who were promoted but not passed MSCIT Exam & as a result they were reverted to the post of LDC/OA are to be restored to the post of U.D.C.(GAD/Acctts.) from the date of reversion.

3. Please note that the time limit beyond 31/12/2011 for passing of MSCIT Exam. will not be extended. Therefore those employees who did not fulfill the condition by 31/12/2011 are to be reverted automatically and no proposals for further extension/consideration are to be submitted to corporate office.
