Sub:- Providing of mobile (GSM) service to M.S.E.D.C.L. employees under free CUG in Maharashtra State. (Including Mumbai)

On approval of competent authority, the work order for providing of mobile (GSM) service to M.S.E.D.C.L. employees under free CUG in Maharashtra State. (Including Mumbai) has been awarded to M/s Vodafone (India) Ltd, who is current service provider to MSEDCL.

The old tariff plan of Rs 98/- changed to new tariff plan of Rs 59/- with change in call, messaging and roaming rates.

The detailed copy of work order, new tariff plan and scope of work is attached here with for reference.

At present new tariff plan has been configured and roll out services is going on, M/s Vodafone is migrating the all company operated company paid (COCP) mobile numbers to the new tariff plan of M/s Vodafone approved by MSEDCL from 1st August 2015 as per mobile numbers billing cycle.

As per contractual terms and conditions the Individual operated individual paid (IOIP) mobile numbers provided to family members of MSEDCL employee under MSEDCL approved tariff plan has to submit the change of plan form with ECS payment confirmation to M/s Vodafone, the necessary facilitation regarding this will be provided by M/s Vodafone.

After change and migration of tariff plan, the first bill will be issued on pro-rata basis (considering both old and new tariff plan) as per billing cycle patterns, however second bill should be generated as per new tariff plan.

The mobile usage financial limit of each category of employee will remain unchanged.
