Sub: Provisions of G.O.74(P)/G.O.111(P) - making changes in the -

- Ref: 1) H.O.Order No.GAD/VII/STF/Gen/A/232/9203 dated 27/2/1975.
 - 2) Correction Slip No.12 dated 4/2/1988. (To G.O.74(P) dated 30/4/1974).
 - 3) G.O.111(P) dated 13/5/1982 read with Circular No.296 dated 25/5/1983.

The Board, by their Resolution No.301 dated 30/11/1995 have accorded approval to modify the existing provisions of G.O.No.74(P), dt. 30/4/1974 and G.O.111(P), dt. 13/5/1982, as under:-

- The preent eligibility period of 8 years service [prescribed by aforesaid C.S.No.12 to G.O.74(P), in respect of those categories] is reduced to 6 years.
- ii) a) The employees/officers who are at present eligible for benefit under G.O.No.74(P) dt. 30/4/74/& G.O.111(P),dt. 43/5/82 and Office Order No. GAD/VII/STF/Gen/232/9203, dt. 27/2/75, only once in their entire service, shall now be held eligible to said benefit twice during the period of their entire service.
 - b) They shall be eligible to get the second benefit after completion of six years reckoned from the date of promotion or from the date of completion of nine years, reckoned from the date from which first benefit was granted, whichever is earlier.

- 2. a) To delete para 4(1) of G.O.111(P), dt. 13/5/1982, read with Circular No.296, dt. 25/5/1983.
 - b) Consequently, Dy. Ex. Engrs. shall be eligible for the second benefit after completion of six years reckoned from the date of promotion or from the date of completion of nine years, reckoned from the date from which first benefit was granted, whichever is earlier.
- 3. Those employees/officers who have already availed or will avail, two benefits admissible either under G.O.No.74(P), dated 30/4/1974 or G.O.111(P), dated 13/5/1982 (destagnaition measures), shall not be eligible for any further benefit during the period of their remaining service, under any of the aforesaid G.Os.
- 4. The officers/employees to whom the benefit/s of the higher post/grade under G.O.No.74(P), dated 30/4/1974 OR G.O.111(P), dated 13/5/1982, are granted, shall not be eligible for the attendant financial as well as non-financial benefits of the said higher posts/grade.
- 5. The Board also delegated powers to the Chairman to make changes/amendments in the provisions of destagnation measures under G.O.111(P), dt.13/5/1982.
- 6. The other provisions, rules and regulations of G.O.No.74(P), dt.30/4/1974 and G.O.111(P), dt.13/5/1982, as amended from time to time, shall remain unchanged.
- 7. The above provisions shall come into force w.e.f. 1/12/1995. The past cases should not be reopened.
